1. Motion by Councilman Kurta, seconded by Deputy Mayor Lasich to approve and adopt Resolution No. 1705 authorizing the submission of an application to the Commonwealth of Pennsylvania Department of Community and Economic Development Keystone Communities Grant Program in the amount of \$20,000 to be used towards the purchase of a new backhoe. **All in favor – 4-0**

2. Motion by Deputy Mayor Lasich, seconded by Councilwoman Johnson to approve a three (3) year professional services contract with Code Enforcement Associates for the purpose of performing building inspections, enforcement of codes under the Commonwealth of Pennsylvania UCC standards, plan reviews, fire code inspections, code compliance inspections, education and training for the City of Clairton. **All in favor – 4-0**


3. Motion by Mayor Lattanzi, seconded by Councilman Kurta appointing Joseph Giles as an Interim or Acting Sergeant for the Clairton Police Department. **All in favor – 4-0**

4. Motion by Deputy Mayor Lasich, seconded by Councilwoman Johnson to approve and ratify expenditures for General Fund Warrant Nos. 06092017, 06162017, 06232017 and 06292017. **All in favor – 4-0**
Councilman Kurta abstained from voting on any Comcast bills
