2. Motion by Councilwoman Lasich, seconded by Deputy Mayor Ford approving Ordinance No.1947 adopting a budget for the Fiscal Year beginning January 1<sup>st</sup>, 2020 and ending December 31<sup>st</sup>, 2020, in accordance with the Charter of the City of Clairton. **All in favor – 5-0**


3. Motion by Councilwoman Johnson-Clemmons, seconded by Councilman Kurta approving Ordinance No. 1948 providing for salaries and wages of employees and officials of the City of Clairton for the period beginning January 1<sup>st</sup>, 2020 and thereafter. **All in favor – 5-0**
4. Motion by Deputy Mayor Ford, seconded by Councilwoman Lasich approving Ordinance No. 1949 fixing the Legislative, Workshop and Re-Organizational meetings schedule of the City of Clairton Council for the year 2020. **All in favor – 5-0**
5. Motion by Councilwoman Lasich, seconded by Deputy Mayor Ford appointing John Vitullo to a five (5) year term on the Board of the Clairton Municipal Authority, with the term to run from January 6<sup>th</sup>, 2020 through January 6<sup>th</sup>, 2025. **All in favor – 5-0**
6. Motion by Deputy Mayor Ford, seconded by Councilwoman Lasich appointing Kevin Johnson to a three (3) year term on the Personnel Board, term to begin on January 1<sup>st</sup>, 2020 and run through December 31<sup>st</sup>, 2022.

Motion by Councilman Kurta, seconded by Councilwoman Lasich to ratify the purchase and installation of the computer system upgrades to the Administrative, Finance and Code Enforcement Departments through the Norman Alan Company at a total cost of \$18,539.36, with payment from the Capital Projects Fund. **All in favor – 5-0**
9. Motion by Deputy Mayor Ford, seconded by Councilman Kurta approving a two year agreement with Robin Gaydos-Behanna for Animal Control Services for the period beginning January 1<sup>st</sup>, 2020 and ending December 31<sup>st</sup>, 2021. **All in favor – 5-0**

10. Motion by Councilwoman Lasich, seconded by Councilwoman Johnson-Clemmons approving a two-year agreement with David Collura for Wildlife Pest Control services for the period beginning January 1<sup>st</sup>, 2020 and ending December 31<sup>st</sup>, 2021. **All in favor – 5-0**

Motion by Deputy Mayor Ford, seconded by Councilwoman Lasich approving Pay Request Application #3 in the amount of \$95,866.12 payable to Burns & Scalo Roofing Company, Inc. for work completed on the City Hall Roof Replacement Project with payment from the Capital Projects Fund. **All in favor – 5-0**
  
12. Motion by Councilman Kurta, seconded by Mayor Lattanzi to approve and ratify expenditures for General Fund Warrant Nos. 11012019 for \$62,775.68, 11082019 for \$55,131.52, 11152019 for \$17,658.56, 11222019 for \$11,028.07 and 11272019 for \$3,316.35. **All in favor – 5-0**
